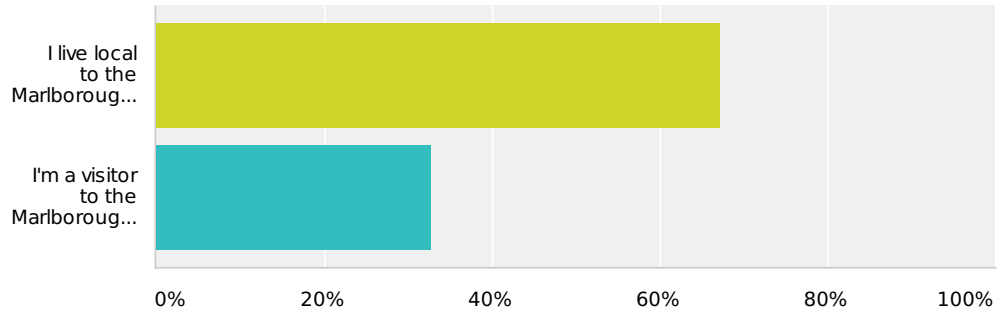

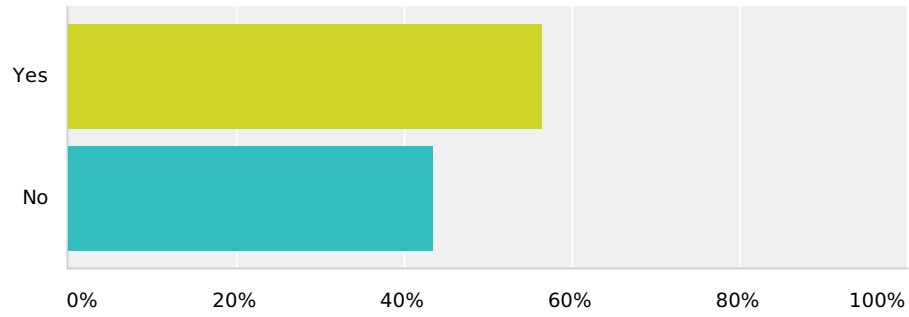

**Q2 Have you read about or heard about farmers working to help wildlife across the Marlborough Downs in a project called "Marlborough Downs Nature Improvement Area"?**

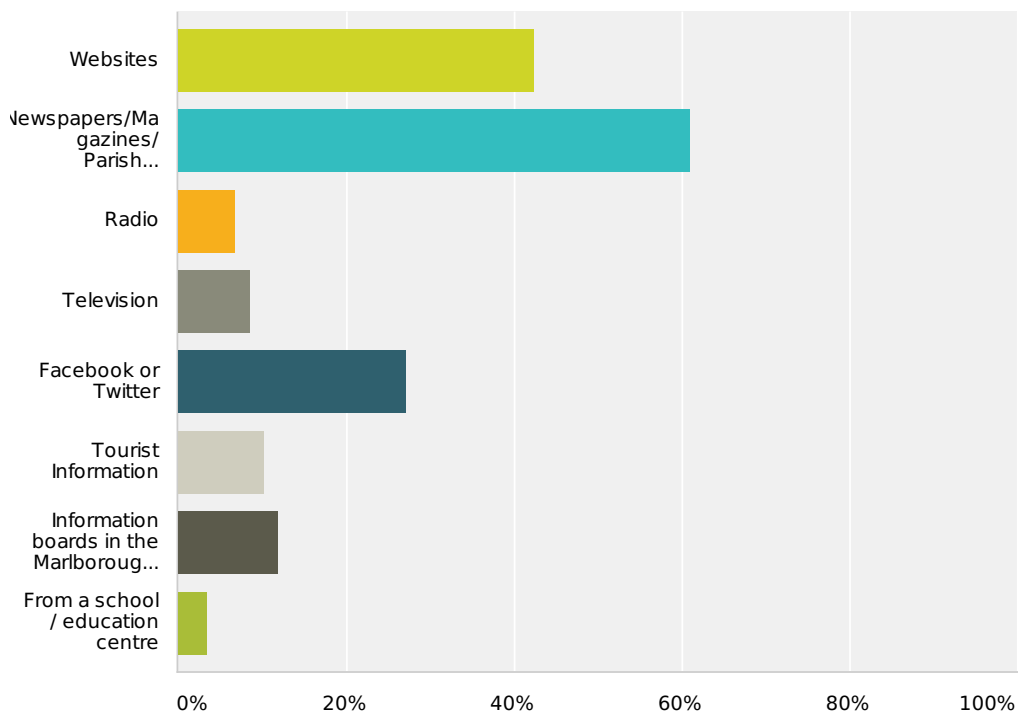

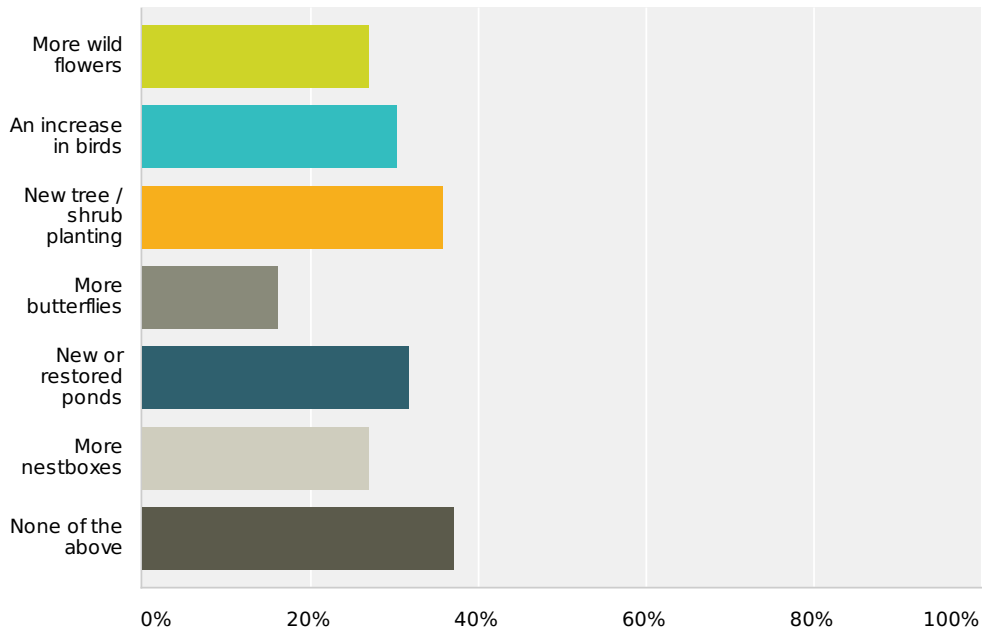

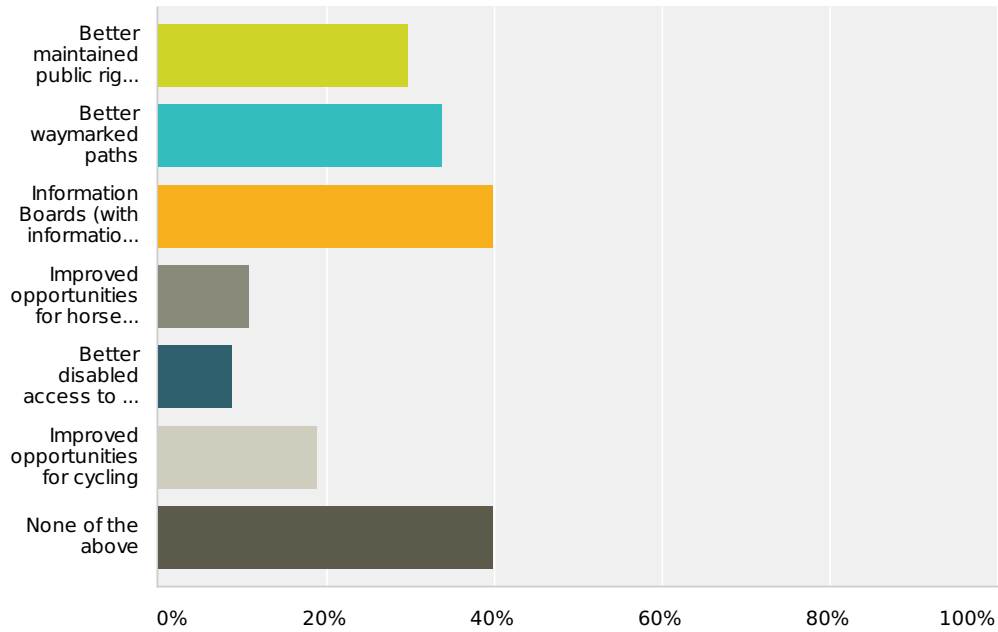

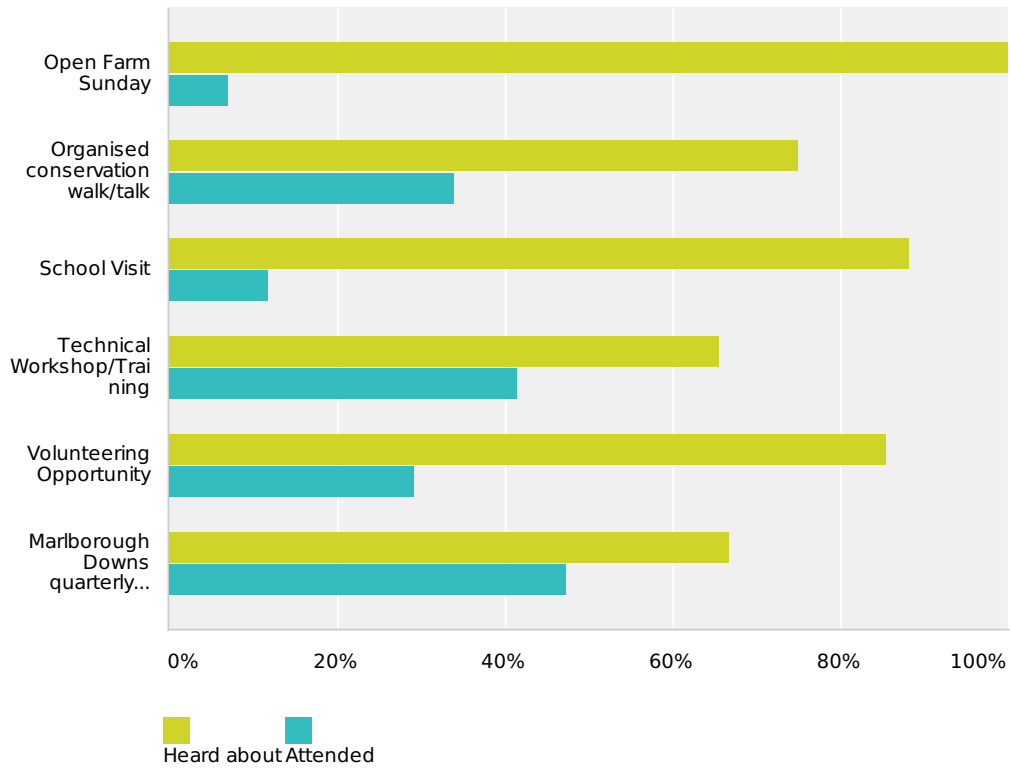
